
A community where all children and families feel supported, safe, and empowered to pursue justice after experiencing abuse.



These interviews are not just vital for the investigative process but also serve as the first step toward healing for many families. Our ability to adapt and remain flexible — whether meeting the needs of local families or accommodating those from outside our region—underscores the critical nature of these services.

TreeTop is here for all, regardless of where they come from or where they are headed.


Annual Report CASES SERVED IN 2024

In 2024, TreeTop Advocacy provided support in 53 cases, each representing a child and their family navigating the devastating impact of abuse, neglect, or other forms of trauma. These numbers reflect not just the volume of our work but also the importance of having dedicated resources for children in need of a voice, safety, and healing.



IMPACTED COUNTIES IN 2024

While TreeTop Advocacy primarily serves the 5th Judicial District, we provided critical services to children from a variety of counties. This includes Eagle (5 cases), Lake (18), and Summit (19), as well as children from Grand, Chaffee, Jefferson, Homeland Security, El Paso, and Fairplay. These statistics demonstrate TreeTop's flexibility and commitment to serving children wherever they are from, ensuring no one is turned away.



GENDER IN PROGRAM IN 2024


Of the children served, 32 identified as female and 21 as male. This distribution reinforces the importance of offering trauma-informed services tailored to the unique needs of all children, regardless of gender.

AGE IN PROGRAM IN 2024

Children of all ages came through TreeTop's doors, from the youngest, ages 0-6 (9 cases), to those navigating their teenage years, ages 13-18 (28 cases). The majority of cases fell within the 13-18 age group, highlighting the critical need to address challenges during formative adolescent years.


TYPES OF ABUSE IN 2024

The cases handled in 2024 reflect the complex and often overlapping forms of harm children face. The majority (29 cases) involved sexual abuse, followed by physical abuse (16 cases). Additionally, 4 children were witnesses to crimes, and 5 suffered from neglect. These numbers underscore the necessity of TreeTop's advocacy and forensic interview services to address a wide spectrum of trauma.



Race and Ethnicity

TreeTop supported children from diverse backgrounds, with 24 identifying as Hispanic, 19 as White, 3 as Black, 6 as mixed-race, and 1 as other. These statistics remind us of the importance of cultural competency and inclusivity in our services, ensuring every child feels understood and respected.



Offenders

The majority of offenders identified in these cases were family members (37), followed by friends, teachers, or acquaintances (9). In 7 cases, the offender was classified as other or unknown. These numbers highlight the devastating reality of abuse often occurring within a child's circle of trust and the critical need for prevention and intervention services.



Secondary Victims

Beyond the children directly served, TreeTop supported 87 secondary victims family members, caregivers, and others present during interviews or engaged in services. This number reflects the ripple effect of trauma and the importance of providing holistic support to entire families as they navigate the path to healing.

COST OF SERVICES: THE VALUE OF YOUR SUPPORT

At TreeTop Advocacy, every dollar you give provides critical support to children and families facing trauma. The cost of services varies—some families need only a few check-ins, while others require ongoing advocacy, housing assistance, or crisis support. No matter the need, your generosity ensures no child is turned away.

The Cost of Care: \$5,000 Per Child

At TreeTop Advocacy, every child's journey to healing is unique, but one thing remains constant — comprehensive, compassionate care is critical. On average, it costs \$5,000 to provide a child and their family with the full range of services needed to navigate crisis and begin healing.

Your contributions make this possible by funding:

- A forensic interview conducted by a trained specialist in a safe, child-friendly space—so a child only has to tell their story once.
- A dedicated family advocate offering personalized support, crisis intervention, and guidance through the legal system.
- Access to mental health resources, including traumainformed therapy referrals and ongoing care coordination.
- Multidisciplinary case support, ensuring collaboration between law enforcement, medical professionals, and child welfare agencies to protect the child's best interests.
- A child-centered, bilingual approach, so language is never a barrier to support.
- Medical care access, including specialized Sexual Assault Nurse Examiner (SANE) services when needed.
- Long-term follow-up to ensure every child and their family receives continued support on the road to recovery.



What We Do and How We Impact Lives

Forensic Interviews: A Safe Space to Share

- Achievement: TreeTop conducted 53 forensic interviews this year, offering children a safe, welcoming environment to share their stories.
- Impact: By reducing the number of times a child has to recount their experience, we help minimize trauma and ensure accurate, compassionate information gathering.
- What's New: Expanded partnerships with law enforcement, DHS, and other agencies have streamlined the process, enhancing collaboration during investigations.

Behavioral Health Partnerships: Expanding Healing Resources

- Achievement: Partnering with Mile High Behavioral Health and other local providers, TreeTop made critical referrals for therapy and counseling.
- Impact: Families accessed targeted behavioral health services to address trauma, reinforce healthy coping mechanisms, and restore trust in relationships.
- What's New: Increased focus on early intervention and therapy options tailored to children's developmental and emotional needs.

Child Advocacy and Support: Navigating the Path Forward

- Achievement: Our Advocates supported all families visiting TreeTop, providing resources and referrals for legal, financial, and mental health needs.
- Impact: Advocates maintained ongoing contact with families, ensuring they were not alone as they navigated the complexities of recovery.
- What's New: The addition of Mariana Wenzel as a Bilingual Case Manager has been transformative, allowing us to better serve Hispanic families and bridge critical communication gaps.

A Cornerstone of TreeTop's Growth

Development and marketing efforts have been instrumental in TreeTop Advocacy's journey, creating opportunities to expand our reach and deepen our impact. FINANCIAL INFORMATION 2024 BUDGET

A Year of Growth and Generosity

In 2024, we experienced a transformative increase in support, both financially and through the dedication of our community. Thanks to the generosity of our donors, partners, and grantmakers, our revenue grew significantly—enabling us to deepen our impact and expand our programs for children and families.

Revenue Highlights

This year, total revenue reached \$458,236.46, a remarkable increase from \$271,649.07 in 2023. This growth was driven by substantial increases in grants, individual donations, and fundraising efforts:

- Grants more than doubled, rising to \$299,610.12, thanks to new funding partnerships and expanded program proposals.
- Donations and fundraising efforts also saw notable growth, reflecting stronger community engagement and successful event outreach.
- Support from local government remained steady at \$82,000, providing crucial stability to our core programs.

Expenses Overview

We remain deeply committed to financial responsibility, ensuring that the majority of our resources are directed toward program delivery. In 2024, expenses totaled \$434,585.08, with nearly 80% allocated to programmatic work:

- Program expenses increased to \$346,241.01, reflecting expanded services and outreach initiatives.
- Marketing investments grew this year to support greater visibility and advocacy impact.
- Management & General costs were carefully managed, ensuring operational efficiency.

The growth we experienced this year reflects a collective belief in our mission and a shared commitment to advocating for every child's right to safety, dignity, and opportunity. With careful stewardship and continued community support, we are entering the next year with strength and hope.

2024: A Year of Firsts and Impact

- Our First Fundraiser: This year, we hosted our inaugural fundraiser, bringing together community members and advocates in support of TreeTop. The event not only raised critical funds but also deepened our connection with the community.
- Colorado Gives Day Success: TreeTop participated in our firstever CO Gives Day campaign, raising over \$8,000 thanks to your generosity. To celebrate, we hosted a community gathering at Mi Casa, where funds were donated to support our mission.
- Collaborations for Awareness: In April, Child Abuse Prevention Month, we partnered with CASA of the Continental Divide and local schools to spread awareness. Events included blue ice cream for locals at Higgles, Pinwheels at Ready Paint Fire, and a series of community-focused activities that engaged families and supporters.
- Creating a Lasting Tribute: This year, we began creating a mural in our facility to recognize our donors with aspen leaves, symbolizing the strength and interconnectedness of our community. This "Leaf Program" will launch fully in 2025, celebrating the donors who make our work possible.

- Critical Services Delivered: Funds raised through donations and events enabled TreeTop to serve 53 children and their families with forensic interviews, advocacy, and support.
- Community Outreach Expanded: With donor support, we grew our partnerships and extended our reach into new areas, making our services more accessible to families across the 5th Judicial District and beyond.
- Spaces of Healing: Contributions also helped enhance our childfriendly facility, ensuring a welcoming, supportive environment for every family who walks through our doors.
